Lifestar responded to 91 911 calls for the month of August in the CAEMS area that were paged out via Columbia County Dispatch. Lifestar provided paramedic intercept service for Cambria EMS once and for Rio EMS once. Lifestar requested mutual aid from Rio EMS five times for the month of August. On 8/23 there were five 911 calls within 1.5 hours which required mutual twice during that time. On 8/29, there were three calls within 30 minutes, Rio was requested for mutual aid to cover the third call that occurred during that time. Lifestar also provided mutual aid to Rio EMS once.
